Check In is from 2-3:30 pm on Sunday.

Check Out is at 12 pm on Friday. Campers must be picked up by that time.

What to Bring:

Bedding, including a twin mattress cover or fitted sheet

All needed toiletry items

Swimwear (one piece for girls or with a dark t-shirt to cover it)

Money for soda

Bibles, pens, pencils, notebook

Snacks that do not require refrigeration are allowed. Please make sure they are able to be sealed after opening to help prevent pests in the cabins.

Cameras, including digital ones, are allowed.

Items Not Allowed:

Electronics including cell phones. ALL CELL PHONES must go home with a parent or be turned in at check in.

Drugs/tobacco of any kind. Prescription/OTC medications will be turned in to the nurse at check in.

Weapons of any kind. This includes pocket knives.

In considering what to bring, please remember the camp is not responsible for lost, stolen or broken items.

Dress Code:

For evening services: Boys may wear jeans, khakis, or dress pants. No shorts or caps/hats in evening services. Girls may wear jeans, khakis, dress pants, capris, or dresses/skirts that reach the knee.

For all times: No short-shorts. Boys should wear shirts at all times, except swimming. Tank tops with open sides are not allowed. Girls may not wear crop/halter tops, see through shirts, or tops with spaghetti straps.

Additional Information:

In case of emergency, parents/guardians may reach their camper at the number above. Note that while campers may not have their phones at camp, if a camper wishes to contact their parent during the camp week, they will be able to do so using the phone of one of the adult volunteers.

If there is a potentially serious illness or injury that may need additional medical care, every effort will be made to contact the parent/guardian before taking them to Urgent Care or the Emergency Room. If a parent cannot be reached, the camp nurse will use best judgment in determining the need for such action.

There is usually one day visitors are allowed to attend evening services. This is offered at the discretion of SICC Youth Camp and is not a guarantee each year. Please ask at check in for this information. Services begin at 7pm and visitors may arrive as early as 6:30pm. Childcare is not provided for these services.

General Rules:

The lake is off-limits unless it is swim time. Girls will not enter the area around the boys' cabins/shower house. Boys will not enter the area around the girls' cabins/shower house.

A swim test is required to swim in the deep end of the lake. The lifeguard's decision is final.

To leave camp for any reason, campers **MUST** notify their counselor and notify them when they return. If a camper is the one driving, keys must be given to their counselor and only be in the camper's possession when they leave. Keys go back to the counselor when the camper returns.

If a problem arises in a cabin/class the counselor/teacher is the first step in handling it. If the issue continues, the counselor/teacher will bring it to the director. If there is still an issue or if it affects the health/safety of the campers, staff, or camp it will be taken to the Board of Directors. It will be at the Board's discretion whether the camper is allowed to stay at camp.

For the safety of all involved, campers will not meet one on one with camp adults. Any times of discipline or spiritual counseling will have two adults present.

Foul language and fighting are not permitted.

Campers will stay with their assigned cabins during class times, evening services and swim times. During free time and meals, they are not required to stay with cabins. However, they are to stay in the approved areas of the camp. Public displays of affection (hand-holding, hugging, kissing) of a romantic nature are not permitted.

Doctrinal Statement:

SICC Youth Camp believes Jesus Christ is the only begotten Son of God, born of a virgin and crucified for our sins. He is resurrected and sitting at the right hand of God to intercede for us. His birth, death, and resurrection provide the only way of salvation to bring us into right relationship with God the Father. **(1 Corinthians 15:3-4, Ephesians 2:8-9)**

We believe in the Trinity; God the Father, Son (Jesus), and Holy Ghost. **(John 15:26)**

We believe in baptism as an outward sign of the inward change. We do not believe in baptism as the way to salvation. If a camper accepts Christ as their savior at camp or prior to and desires baptism, a class explaining baptism will be provided. With parental permission, the camper may be baptized on Friday at 11:45am before camp ends. **(Matthew 28:19)**

SICC Youth Camp believes in marriage, established by God, as a union between one man and one woman. **(Genesis 2:24, Ephesians 5:31)**. Further, SICC Youth Camp holds that, in accordance with scripture, sexual intimacy/activity is appropriate only in the marriage relationship. **(1 Corinthians 7:2, Hebrews 13:4)**. SICC Youth Camp believes God has created two distinct and complimentary genders, male and female, and each person is created in accordance with God's perfect design. **(Genesis 1:27, Matthew 19:4)**. Accordingly, SICC Youth Camp views the following behaviors as inappropriate and contrary to scripture:

1. Any sexual intimacy or sexual act between individuals who are not married to each other.
2. Any marriage or civil union that is not between one man and one woman.
3. Any attempt to adopt or present as a different gender than that at birth.
4. Any other activity, teaching, or behavior that is contrary to a biblical view of marriage, gender and/or appropriate behavior as outlined in this provision.

All staff involved in the ministry of SICC Youth Camp are expected to uphold the ministry's perspective on marriage, gender, sexual intimacy and appropriate behavior as set forth in this statement. All camp operations, including the assignment of cabins and classes will be done according to this provision.
